By analyzing the basic rate mentioned in the tender and the quoted rate of M/s Dronacharya Sewa Sansthan and M/s SJTS International Pvt. 1td., tender evaluation committee found that both L1 have quoted base rate without including statutory payment and service charge in their quote. On enquiry, both the companies have admitted the same and has stated that they have no objection in awarding the tender to L2 since the Basic rate quoted by them cannot be fulfilled (vide letter No.DSS/2234/19 dated 19-03-2020 and No.SJTS/2311/18 dated 18-03-2020). Legal opinion was sought by the Member Secretary in this regard and the Legal Advisor has given confirmation that since the L1 has expressed no objection for awarding the tender to L2 bidder due to their inability to fulfill the tender conditions, the contract can be awarded to L2 i.e We Help Security. Relevant documents are attached for information.

Leela Scottish Lace Pvt. Ltd. Mumbai, Owner of RS No. 279, Kannur Village I, GLR Sy. No. 1, B2 class land, Cannanore Cantonment has done unauthorised construction in his premises. RS No. 279, consisting of house 21C & 21D admeasuring 2793 m2 (0.6901 acres) outside civil area. The unauthorised construction is isolated away from the building blocks 21C & 21D and situated on the South-western end of the plot. The following is a brief description of the unauthorised constructions carried out:-

- Security guard restroom with attached toilet admeasuring 4.06m X 2.17m X
 3.05m height constructed with reinforced cement concrete columns, beams, flooring slab and walls in Cement Concrete block masonry.
- 2. Two cement concrete masonry platforms admeasuring 3m X 1.43m X 0.37m each mounted with a functioning DG set. The combined area of both the CC platforms are covered with translucent sheet roofing and covered with grilled windows on sides

Vide: letter No. 2569/UC/B.21.C/2019 dated 15.10.2019, the applicant was required to showcause. Vide: the applicant's letter No. Nil dated 26.10.2019 he requested for forgiving the illegalities and asked for permission to install DG set. Further an Office letter No. RSNo.279/H.No.21C/2019 (2569/UC/B-21C/2019) dated 21.04.2020 asking him to send drawings of the unauthorised construction in triplicate for regularisation within 15 days. Further no correspondence has been received from the part of the owner.

The unauthorised construction falls in CRZ II area and attracts CRZ clearance. The construction is a violation of CRZ rules. It is required to issue notice under section 248 of Cantonments Act, besides prosecution.
