# Agenda 17 : Provision of Precast RCC covering slabs to open drains in Burnacherry along with repair to internal drains

Vide: above CBR No. 12 dated 01.10.2018, the TC for maintenance of storm water drains was approved to the lowest bid of contractor T. Sujith. Further, vide: CBR no. 24 dated 09.11.2018 the estimates for the same were approved. As per requirements of SLRM project, under advice from Mr Srinivasan the drains were constructed as open drains for Canna plantation. However, as work progressed in March 2020, the Board members of Ward I, Ratheesh Antony submitted a letter asking for inclusion of covering slabs due to danger of kids falling in drains. Ward members Deepa Baiju and member Sheeba also raised the same request verbally. Also, additional repairs to internal drains were required to be carried out in Bazar area. Hence, the work of providing RCC covering slabs and repairs to internal drains was carried out in March 2019. The work order No. 3/2018-19 amounted to Rs. 7,73,000. However, a Board meeting could not be convened before approval of the work order. The election commission code of conduct for general elections were applicable at the time. Further vide CEIL inspection report No.s CEIL/9595(G)/JVB/004, 005 & 006 dated 31.07.2020, some observations were made regarding the thickness of precast RCC slabs not being the specified 100 mm at certain places. The average thickness at Burnacherry Bazar road southside drain was found to be 95mm, near BEUMP school, 92mm, near orthodox church 91mm, Near GL WII to Convent road 77mm. entered in MB 19 pg no.s 45-67. It was found out that the thickness was reduced at the areas due to account for depression at entrance to gates in civil area. The explanation report was sent to CEIL and CEIL issued inspection release report No.s CEIL/9617/JVB/228, 229, 230 & 231 dated 19.08.2020. Subsequently, the deductions to be made to the bill on account of decrease in thickness of slab was worked out. The bill amount for the work order No. 3 amounts to Rs. 7,31,891 as recorded in MB 19 pg No.s 45-79 and after making deductions for the decrease in slab thickness as mentioned in CEIL's report.
