1. CONSTITUTION OF THE BOARD

2. ELECTIONS

No election was held during the year.

3. REVENUE:

(i) Measures taken to Augment Revenue

Triennial Assessment of properties for the period 2019-22 has been completed. Revenue has been increased by 30%.

(ii) Comparison of Tax Rates with Neighboring Municipality Tax rates:

All taxes levied by the adjoining Municipality are being levied by Cantonment Board and the taxation is higher in Cantonment than in the Municipality.

(iii) Percentage of Recovery of Property Tax against Total Demand during the year.

4. WATER SUPPLY

The Board has its own water supply arrangements. Apart from individual connections, the Board also maintains 20 public stand posts and 8 open wells. Per capita supply is 200 liters per day.

6. EDUCATION:

The Board does not have any school.

7. ENVIRONMENT AND SANITATION :

(i) General sanitation

General sanitation in the Cantonment remained satisfactory.

(ii) Ban on Use of Polythene

Board has passed a resolution to ban on use of polythene bag and regular Inspections are being conducted in all the Shops located in Cantonment area.

(iii) Efforts made for improvement of Solid Waste Management.

Door-to-door garbage collection is done daily. Blue and green dustbins supplied to all houses for facilitating segregation of solid waste at source. The bio degradable wastes are converted into manure through Solid Liquid Resource Management project established and maintained by the Cantonment Board.

(iv) Tree Plantation

50 saplings were planted during the year and survival rate was 100%.

8. PUBLIC HEALTH

(i) Hospital and Dispensaries

The Board does not maintain any hospital or dispensary. District General Civil Hospital of the State Government is located within the Cantonment area.

(ii) Special measures taken for Senior Citizens

Senior Citizens are taken care of by District Hospital.

(iv) Health care measures for Cantonment Board Employees & their dependents

Facilities of District Hospital are availed of all by Cantonment employees and their dependents.

9. GENERAL ADMINISTRATION

(i) Status of Implementation of New Pension Scheme

New Pension Scheme has been implemented.

(ii) Public Grievance Redressal Mechanism

Mobile app is designed for grievances redressal which is open to general public.

(iii) Audit of Accounts

Audit of Accounts has been carried out upto November 2019 and has been found satisfactory.

(iv) Any other initiative(s) in public interest

Indira Gandhi National Old Age Pension Scheme is implemented in the Cantonment area. The Board forwarded senior citizen's pension cases to District authorities of Kerala and got approved for 12 pensions for the year.

10. LAND RECORDS MANAGEMENT AND MODERNIZATION

(i) Creation of IT Section

IT section has been created with one Computer Programmer with necessary hardware and allied infrastructure.

(ii) Status of Raksha Bhomi Implementation.

Raksha Bhoomi 5.0 has been implemented.

(iii) Document Management System

File Management System and Dak Management System have been installed and are being used regularly.

(iv) Steps taken to automate office processes

Birth, Death and Marriage Registration is computerized. Online collection of Property tax and water tax has been implemented.

(v) Digitization of office records.

The digitization of important documents/ records has been completed and sent to AU&RC, Delhi Cantt. Total 673 files were digitized. 07 files have been digitized during the year.

11. MARKETS

The Board maintains 26 shops in Cantonment Shopping Complex and 10 shops near Bus Stand.

12. FIRE FIGHTING

The Board gets support for firefighting from the District Fire Station & Rescue Station of the State Government which is located in Cantonment area. The Board has installed 7 fire extinguishers in office premises. No separate fire-fighting establishment is maintained by the Board.

13. BIRTHS AND DEATHS

The District Hospital is situated in Cantonment area. Therefore, total number of 3753 births and 448 deaths were registered during the year. However, 13 Births and 14 Death cases registered pertaining to Cantonment area.
