E-AUCTION NOTICE

It is proposed to dispose 53.Nos. of various types of fallen/uprooted/dried trees/standing on various sites of Cannanore Cantonment Board, by public **e-auction** (www.eauction.gov.in) on **04.03.2022** at **1000 Hrs to 1700 Hrs**. The details of trees are as follows:-

TERMS & CONDITIONS OF SALE:-

- The intending bidders are requested to visit <https://eauction.gov.in/> website for registering/creating profile for participating in the auction. Only those bidders/contractors who will produce hard copies of their PAN card and residential proof (Aadhaar card/Voter's ID card/Passport/Drivers' License) for verification along with proof of EMD payment of Rs. 1,23,076/- (Rupees One Lakhs Twenty Three Thousand and Seventy Six only) to **Chief Executive Officer, Cantonment Board Cannanore** via self generation of challan mode in e-chhawani portal on or before **28/02/2022 11.59 PM** shall be considered eligible for participating in the auction. List of documents required for online bidding are attached **Annexure "A"**. The base rate of the fallen/uprooted/dried trees mentioned above is **Rs.20,01,228/- + GST + 5% Forest Development tax**. TCS will be deducted as per rules.
- The intending bidders will be allowed to inspect the condition of the trees and location on or before **25.02.2022** in consultation with Cannanore Cantonment Board, Kannur between **1030 hrs to 1430 hrs**.
- Subject to realization of the minimum reserve price, sale shall be made to the highest bidder with the approval of the competent authority. After the approval of the highest bid by the Chief Executive Officer, 10 % of bid amount (as security deposit via self generation challan mode in e-Chhawani portal) and 50% of the bid amount should be deposited to

Cannanore Cantonment Board **within 02 (two) working days** through vial online payment mode through e-Chhawani portal, proof of which should be provided to the office of Chief Executive Officer, Cantonment Board Cannanore. The balance amount should be deposited on approval of the highest bid by the competent authority within the specified time as mentioned in the offer letter. In any case, the bid amount not deposited within the stipulated period, the EMD and 50% of the bid money as the case shall be, will be liable to be forfeited and the contractor shall be blacklisted from the list of contractors and the second highest bidder may be considered. All the payments should be done through online payment method via e-Chhawani portal.

5. The security deposit will be refunded after completion of the removal of trees, provided the conditions are fulfilled by the highest bidder, subject to receipt of completion report from the office of Chief Executive Officer, Cantonment Board Cannanore. In case any damage to Govt. property is reported by the unit, the security deposit will be either forfeited or adjusted against the loss.
6. Before the actual cutting/removal of trees, authorized personnel from the unit concerned will show the location and the exact marked/stamped trees standing on the site to the highest bidder. After completion of the removal of trees, the contractor will submit to the office of Chief Executive Officer, Cantonment Board Cannanore, a confirmation letter issued by the concerned Officer(Overseer, Cantonment Board) to the effect that only those trees indicated in the auction notice have been removed by the contractor and no other trees have been cut and removed from the premises/land of Cannanore Cantonment Board.
7. The highest bidder is also required to deposit GST, income tax towards sale of timber/ forest Department tax/ any other taxes as applicable to the Chief Executive Officer, Cantonment Board Cannanore. The removal permission shall be issued only after the challans/proofs of payment of applicable taxes have been produced to the office of the Chief Executive Officer, Cantonment Board Cannanore.
8. The contractor is required to cut/remove the auctioned trees within **30 working days** from the date the working permission received by him. However, the same can be extended at the discretion of Chief Executive Officer, Cantonment Board Cannanore on written request from the contractor or at the CEO's discretion.
9. To facilitate smooth transportation, transit pass, if required from the concerned forest authorities, shall be the responsibility of the successful bidder.
10. The highest bidder shall inform about the details of specific numbers of Persons/Vehicles/ machinery being deployed to the concerned authorities (Chief Executive Officer, Cantonment Board Cannanore) before entering the premises and obtain security passes/permission letter etc from Chief Executive Officer, Cantonment Board Cannanore. The highest bidder shall compulsorily register the movement of his trucks with Chief Executive Officer, Cantonment Board Cannanore.
11. No Govt. property shall be damaged while removing the trees by the contractor or his men. The contractor is solely responsible for works of his servants/workers. Chief Executive Officer, Cantonment Board Cannanore does not take any responsibility whatsoever. The contractors have to follow the rules/regulations of Cantonment Board Cannanore.

12. Should the purchaser fail to fulfill his contract obligation under the sale, the amount paid by him, will be forfeited and the trees sold to him, but not removed from the site within the stipulated time, will be put to re-auction at his risk and cost.
13. In case approval from the competent authority gets delayed and the trees auctioned fall/are damaged, this office shall not be responsible for the same and no claims/correspondence in this regard will be entertained.
14. If the contractor/bidders participate in the auction proceedings, it will be considered that he is aware and agrees to all the terms and conditions of the auction and that he has inspected all the trees to be auctioned. Any objections regarding the trees/condition of trees/location of trees etc will not be entertained subsequent to the auction.
15. Any person/bidder/contractor found indulging in unfair means adversely affecting the bidding process will be liable for legal and punitive action and shall be debarred from participating in this auction as well as future auctions conducted by this office.
16. The bidder/contractors against whom government dues are outstanding in respect of any previous auction and who has/have failed to clear the dues, shall not be allowed to participate in the auction until the outstanding dues are cleared.
17. The Chief Executive Officer, Cantonment Board Cannanore reserves the right to reject/accept any bid, at any stage, without assigning any reasons.
18. In case of any dispute arising from the said sale, the decision of the Chief Executive Officer, Cantonment Board Cannanore will be final.
