
The E-tender should be uploaded with the certified documentary proof of

3. Bank Solvency Certificate for a minimum of 25% of the estimated cost of work from Nationalised/ Scheduled Banks,
- 4.Income Tax Permanent Account Number/ TAN & EPF registration and
5. The list of technical staff employed and details of machinery possessed

Other details and particular regarding conditions of Tenders can be had from the office of the Cantonment Board, Cannanore on working day during working hours. The Budget provision (indicating the estimated cost of work) is purely tentative and not binding on the Cantonment Board/ Chief Executive Officer to actually place work orders accordingly. The period of contract may change based on the assessment of the progress of work or as when instructed by the CEO/Board. The charges for regular periodic Third Party inspection will be borne by the

Board, but however charges for periodical tests to be carried as per the instructions of the Third Party inspectors will be contractor's responsibility.
